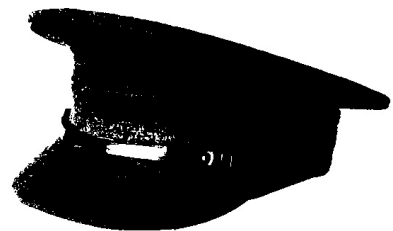
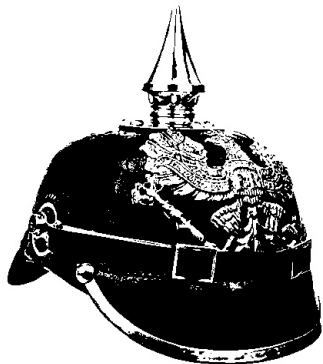

Waiver & Release of Liability Agreement

I, the undersigned, acknowledge, agree and understand that:

- 1. Voluntarily and of my own free will, I elect to participate as a guest of the Royal Sussex Society/35th Regiment of Foot and the State of New Jersey, Department of Environmental Protection, Ringwood State Park.
- 2. I understand that there are certain risks and hazards involved in participating in historical reenactment that may result in injury to me or others, including, but not limited to those hazards associated with the discharge of blank firing firearms and physical activities which simulate a combat scenario.
- 3. I understand that I will take every precaution to ensure the safety of my person and of those around me by adhering to basic safety procedures. In the event of an emergency, I will immediately contact 911, and will also contact the **Ringwood State Park Office at 973-962-2240**. In the event that an emergency occurs outside the hours of 0800-1630 guests will contact **Trenton Dispatch at 877 WARN-DEP**.

Further, I, the undersigned, agree that:

- 1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while acting as a guest of the Royal Sussex Society/35th Regiment of Foot and the State of New Jersey, Department of Environmental Protection, Ringwood State Park, (b) while serving in any capacity within the event program on August 6th, 2017, or by other participants, and (c) while on or upon the premises of any and all of the sites arranged for by the Royal Sussex Society or associated sponsor for living history and historical reenactment.
- 2. I release, discharge, and agree not to sue or hold liable the Royal Sussex Society/35th Regiment of Foot, its officers, members, guests, and the State of New Jersey, Department of Environmental Protection, Ringwood State Park, or any of its affiliates, employees, volunteers, agents, or directors, the property owner, or any likewise associated participating organizations, persons or entities associated therein with the aforementioned for any claim, damages, costs, or cause of action which I have or may have in the future as a result of injuries or damages, sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract, or wrongful conduct of the parties hereby released.
- 3. By affixing my signature, I agree that I am bound by this contract and, should I bring suit against any of the aforementioned entities on any claim, or matter, fail to obtain a judgment against those entities that I shall be liable to them for all attorney fees paid by those entities in defending the suit.

I acknowledge that I have read and that I understand every provision in this waiver and release of liability agreement and agree to abide by them. If I am under the age of 18, I have the consent of my parent or legal guardian.
